

## Privacy & Cookies Policy of [www.fpdancecamp.com](http://www.fpdancecamp.com)

- 1) Personal Data Administrator and [www.fpdancecamp.com](http://www.fpdancecamp.com) Operator („Service Operator”) is Karol Niecikowski Fair Play Art registered Central Registration and Information on Business managed by the minister in charge of economy, as well as in the Registry of Tour Operators and Travel Agents under the no. 04/12. - 2) Some features of the Service are also available at [www.fairplayregister.com](http://www.fairplayregister.com). They are under the same Privacy Policy, as the content of [www.fpdancecamp.com](http://www.fpdancecamp.com).
- 3) Service performs the functions to obtain information about users and their behavior in the following way:
  - a. By voluntarily entered information in forms.
  - b. By stored cookie files in the terminal devices (called "Cookies")
  - c. By collecting logs, web server by web host.
  - d. In the case of purchase and registration process on the Website - by collecting the following data: name, date of birth, company name, registered address, mailing address, email address, phone number. Providing these data is voluntary, but at the same time necessary for the registration and purchase through the Service.
- 4) The information in forms.
  - a. The website collects information provided voluntarily by the user.
  - b. The service can also save the connection settings (marking time, IP address).
  - c. Data in the form are not shared with third parties other than with the consent of the user.
  - d. The data contained in this form are processed in the order resulting from the function of a particular form, eg. in order to process your request, shopping or business contact.
  - e. Data are also proceed:
    - for accounting and tax purposes;
    - in order to respond to requests submitted to Customer Service or by contact form, when they are not directly related to the implementation of the agreement,
    - in order to organize competitions and promotional campaigns in which users have agreed to participate.
  - f. With the consent of the user data given in the forms can be shared with following entities for the purpose of service purchased by the user:

- 5) The right of opposition.

The user has the right to object the processing of the personal data when:

  - a. The processing of the data is based on legitimate interest or for statistical purposes and the opposition is justified by particular situation,
  - b. Personal data is processed for marketing purposes and it's profiled for these purposes.
6. Data deletion.

The user has the access to his data, has the right rectify, delete or limit processing, the right to object, the right to lodge a complaint to the supervisory entity. These rights can be used when:

  - a. regarding the request for data rectification: user data is incorrect or incomplete;
  - b. regarding the request for data deletion: data will no longer be necessary for the purposes they were collected for by the Service operator; the consent for data processing will be withdrawn; processing of the data will be objected; data will be processed unlawfully; the data should be deleted in order to fulfill the obligation resulting from the law or the data were collected in connection with the provision of electronic services offered to the child;
  - c. regarding the request to limit the processing of data: the data is incorrect - the user may demand the restriction of data processing for a period, when correctness of this data is checked; the data will be processed unlawfully, but the user doesn't want it to be removed; the data will no longer be needed by the Service Operator but will be needed for the user to defend or claim;
  - d. regarding the request for transfer of data: the processing of user's data takes place on the basis of his consent or the contract concluded with them, when this processing is carried out automatically.

The User has the right to complain in relation to the processing of personal data by the Service Operator to the supervisory entity, which is General Inspector for Personal Data Protection (address: General Inspector of Personal Data Protection, Stawki Street 2, 00-193 Warsaw, Poland).

7. Information about the files cookies.
  - a. The Service uses cookies.
  - b. Cookies files (called. "Cookies") are computer data, in particular text files that are stored in the terminal equipment of the Service User and are intended for the use of the websites of the Service. Cookies

typically contain the name of the website from which time store them on a terminal device and a unique number.

- c. The entity putting on the device of the Service User cookies and receiving access to them is the operator of the Website.
  - d. Cookies are used for the following purposes:
    - Produce statistics that help to understand how the Service Users benefit from web pages, which allows improving their structure and content;
    - Maintenance of the Service User sessions.
  - e. There are two basic types of cookies used in the service: "session" (session cookies) and "permanent" (persistent cookies). Cookies "Session" are temporary files that are stored in the terminal equipment of a user to log out time, leave the website or disable the software (web browser). "Permanent" cookies are stored in the terminal equipment of a user for the time specified in the parameters of cookies or until their removal by the user.
  - f. Software to browse the web (browser) usually allows by default storage of cookies in the terminal equipment of a user. Service Users can change the settings in this area. The web browser allows you to delete cookies. Users also automatically block cookies details, see the help or documentation web browser.
  - g. Restrictions on the use of cookies may affect some of the functionality available on the websites of the Service.
  - h. Cookies putted on the Service User devices may be used also by cooperating with the operator of the Service advertisers and partners.
  - i. We recommend reading the privacy policies of these companies to learn how to use the cookies used in statistics: Google Analytics Privacy Policy
  - j. Cookies can be used by ad networks, in particular, the Network Google to display ads adjusted to the way of using the Service. For this purpose can maintain information about the user navigation path or the time remaining on the page.
  - k. In terms of information about user preferences collected by the Google Display Network, user can view and edit information derived from cookies using the tool: <https://www.google.com/ads/preferences/>
8. Web server logs.
- a. Information about some of the behaviors of users are subject to logon the server layer. These data are used solely to administer the site and to ensure the most efficient service provided hosting services.
  - b. Browsed resources are identified by URLs. In addition, notation may be:
    - The time of request,
    - Time to send a response,
    - The name of the client station - identification performed by the HTTP protocol,
    - Information about errors that occurred in the implementation of the HTTP transaction,
    - URL of the page previously visited by the user (referrer link) - where there has been a transition to the Service by reference,
    - Information about the user's browser,
    - IP address information.
  - c. The above data are not associated with individual persons.
  - d. The above data are used only for server administration.
9. The release of the data.
- a. The data must be made available to external entities only within the limits permitted by law.
  - b. Data identifiable natural person are available off the consent of that person.
  - c. The operator may be required to provide information collected by the Service authorized authorities to comply with lawful requests to the extent resulting from the request.
10. File Management cookies - how express and retract consent?
- a. If users do not wish to receive cookies, may change the browser settings. We reserve the cookies are disabled required for authentication processes, security, maintenance preferences may make it difficult, and in extreme cases may prevent the use of websites
